## c. Staff recommends approval and passage of the following Resolutions:

1. Resolution No. 21-65 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA VERNE, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, APPROVING THE FINAL MAP FOR PARCEL MAP 83419, (CASE NO. 33-21TPM), A REQUEST TO SUBDIVIDE THE PARCEL AT 2317-2371 FOOTHILL BOULEVARD - On June 1, 2021 the Development Review Committee (DRC) approved Tentative Parcel Map No. 83419 (Case 33-21 TPM) to subdivide a single parcel into two new parcels. This proposed configuration will allow the owner of the property (La Verne Venture I, LLC) to separate the existing medical uses which includes the anchor tenant Pomona Valley Health Center from the existing retail uses in the shopping center.

City Engineer Howing recommends that the City Council approve Resolution No, 21-65, approving the Final Parcel Map No. 83419 (2317-2371 Foothill Boulevard) and direct staff to sign the map as to its conformance with the Subdivision Map Act and City Municipal Code.

d. Ordinance No. 1100 - Flavored Tobacco Ordinance - The City Council, following discussion and debate on the Ordinance, introduced Ordinance No. 1100 banning the sale of flavored tobacco products in La Verne. The Ordinance is being returned to the agenda for first reading as it was discovered that the exemption for hookah establishments was omitted from the Ordinance. The corrected text has been inserted at Section 4 F.

City Attorney Kress recommends that the Ordinance No. 1100, amending Chapter 5.37 (Tobacco Retailers) of Title 5 (Business Taxes, Licenses and Regulations) of the La Verne Municipal Code to prohibit the sale of flavored tobacco products and amending Chapter 1,08 (Definitions) of Title 1, be introduced and to waive further reading and placed on first reading.

<u>Ordinance No. 1100</u> - AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LA VERNE, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA AMENDING CHAPTER 5.37 (TOBACCO RETAILERS) OF TITLE 5 (BUSINESS TAXES, LICENSES AND REGULATIONS) OF THE LA VERNE MUNICIPAL CODE TO PROHIBIT THE SALE OF FLAVORED TOBACCO PRODUCTS AND AMENDING CHAPTER 1.08 (DEFINITIONS) OF TITLE 1 (GENERAL PROVISIONS).

One critical remaining step is City Council's approval of his employment agreement. While most of the terms of employment fall within the authorities of the City's Salary and Benefits Resolution for Executive Management, there are several conditions that require Council consideration. As such, the attached agreement has been prepared by legal counsel and reviewed by the candidate for Council consideration.

# STAFF RECOMMENDATION:

The City Council should approve Resolution No. 21-63, an agreement with Christopher Nigg confirming his employment terms as the City's Fire Chief.

12. ADJOURNMENT in memory of Joe Torchia, a long-time La Verne resident who passed away on Friday, July 9, 2021. Joe was born on May 25, 1949 in Perth Amboy, New Jersey. Joe and his wife, Cathy, along with their two daughters, Cari and Lori, moved to La Verne in April, 1978 where he resided in the same home for 43 years. Joe began his involvement with the youth sports in 1986. He held many positions on the LV/SD Pop Warner Football Executive Board. From 1991 to 1995, Joe was also actively involved at Bonita High School. His wife was the Rally advisor and he quickly earned the title of "Rally Dad." Joe served as one of the founding members of the Sports Park Committee. He was instrumental in the rehabilitation of Glenn Davis stadium in 1996, the renovation of the La Verne Aquatics Center in 1997, and the building of the skate park. He received the 1st Jim Scranton Pride of La Verne Award in 1999. Joe served as a member of the La Verne Heritage Foundation. where he helped bring the windmill to the park that many enjoy today. Throughout his life, Joe had many career adventures ranging from owning a Union 76 Gas Station in Alhambra, an auto repair shop in San Dimas, working as a bus mechanic for the Covina Valley School District, and a Motor Carrier Specialist for the California Highway Patrol. He retired from the CHP in May 2015. He is survived by his wife of 52 years Cathy, his daughters Cari Haas and Lori Young, his son-in-laws Mike Haas and Mike Young, and his pride and joy grandchildren, Saydee, Shyanne, Madison, Mason and Garrett.
