### 4. **PRESENTATIONS**

**Southern California Association of Governments (SCAG) Presentation** – The City of La Verne participated with SCAG as part of a region wide EV Infrastructure Plan. The primary objective of the Plan is to understand how to best continue fostering EV adoption in alignment with the State's goals. Throughout the project, SCAG completed a region wide EV charging station suitability analysis, conducted site evaluations, engaged the public and stakeholders to understand barriers to EV adoption, reviewed the City's policies related to streamlined EV permitting, and developed educational resources for the public, City staff, and property owners. This presentation will review the key results of this project as it relates to the City of La Verne.

  - b. <u>Register of Audited Demands</u> in the amount of \$656,612.38 dated December 29, 2022, in the amount of \$1,942,938.71 dated January 5, 2023, in the amount of \$654,313.46 dated January 12, 2023, in the amount of \$1,339,865.12 dated January 19, 2023, and in the amount of \$555,070.85, dated January 26, 2023, for *approval.*
  - c. <u>City of La Verne Treasurer's Report for Quarter's Ending September 30, 2022, and</u> <u>December 31, 2022</u> - The Treasurer's Reports for Quarter's ending September 30, 2022, and December 31, 2022, are submitted for City Council to receive and file per City of La Verne Administrative Regulation Number 215, the Statement of Investment Policy, and the State of California's Government Code (GC) Section 53646.

Staff recommends that the City Council receive and file the Treasurer's Report for the Quarter's ending September 30, 2022, and December 31, 2022.

d. <u>Purchase of Grant Funded Portable Vehicle Barriers</u> - The Department received grant funding from a State Homeland Security Program (SHSP) to purchase protection barriers to be used to strengthen public safety.

# Staff recommends that the City Council approve the purchase of an eight-barrier trailer kit from Meridian Rapid Defense Group for \$86,633.48; and authorize the City Manager to execute applicable documents.

e. <u>Additional Compensation for Utility Supervisor Assigned to Standby</u> - After the promotion of employee Ralph Hernandez to Utility Supervisor, the City has a need for an employee to serve in a back-up standby duty role. Since no other non-exempt employees currently qualify for this role, the City Council is requested to authorize, by minute order, additional compensation for Mr. Hernandez to serve on standby when needed.

Staff recommends that the City Council authorize, by minute order, that Ralph Hernandez receive additional compensation as provided under Article 12 of the La Verne City Employees' Association Memorandum of Understanding when assigned to standby duty.

### f. Staff recommends approval and passage of the following Resolutions:

 <u>Resolution No. 23-06</u> - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA VERNE, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, DECLARING THAT WEEDS, BRUSH, RUBBISH AND REFUSE UPON OR IN FRONT OF SPECIFIED PROPERTY IN THE CITY ARE A SEASONAL AND RECURRENT PUBLIC NUISANCE, AND DECLARING ITS INTENTION TO PROVIDE FOR THE ABATEMENT THEREOF -Each year, the County of Los Angeles Department of Agricultural Commissioner/Weights & Measures, conducts inspections for weeds, brush, rubbish, and refuse on public and private property that may be considered a seasonal and recurrent nuisance. A list of properties is provided to the City for review. City Council is required to declare its intention to provide for this abatement and set a public hearing for affected property owners to register objections to said abatement.

Staff recommends that the City Council adopt Resolution No. 23-06, declaring the intention to provide for the abatement of weeds, brush, rubbish, and refuse, and setting a public hearing for Tuesday, February 21, 2023, at 6:30 p.m.

2. <u>Resolution No. 23-07</u> - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA VERNE, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AUTHORIZING AN AGREEMENT WITH THE CITY OF PASADENA FOR THE LA VERNE POLICE DEPARTMENT TO PROVIDE SUPPLEMENTAL LAW ENFORCEMENT SERVICES FOR A TERM OF THREE (3) YEARS RELATING TO MAJOR EVENTS AT THE ROSE BOWL - The City of Pasadena approached the City of La Verne requesting to enter into a contract to provide supplemental law enforcement functions relating to major events, such as the Rose Bowl, the Tournament of Roses Parade, and other events taking place at the Rose Bowl Stadium in the City of Pasadena. This is the third extension of this agreement between the City of Pasadena and the City of La Verne.

Staff recommends that the City Council approve Resolution No. 23-07, authorizing the agreement between the City of La Verne and the City of Pasadena, for supplemental law enforcement services for a term of three (3) years and authorize the City Manager to execute the agreement.

**Discussion and Potential Consideration Related Directly Elected Mayor Position** - Council Member Johnson has requested an item to discuss and consider revisiting a directly elected mayor in-lieu of the current rotational system set forth by Ordinance No. 1107 adopted on December 6, 2021, by a 4-1 vote of the City Council. This item will allow discussion and for the City Council to provide appropriate direction.

#### STAFF RECOMMENDATION:

That the City Council provide direction related to reestablishing a directly elected Mayor position.
