3. AWARD TO HIGH STANDARD AUTOMOTIVE, LLC, FOR OUTFITTING OF FOUR POLICE INTERCEPTORS - This action will award a purchase order to High Standard Automotive, LLC, in the amount of \$79,926.87 for Police patrol vehicle outfitting (lighting package, internal equipment, radio/video interchange) and decommissioning of police units being replaced.

RECOMMENDATION: That the City Council award a purchase order to High Standard Automotive LLC, in the amount of \$79,926.87 for outfitting of four Police vehicles.

4. RESOLUTION 23-70, EXPRESSING SUPPORT FOR ACTIONS TO FURTHER STRENGTHEN LOCAL DEMOCRACY, AUTHORITY, AND CONTROL AS RELATED TO LOCAL ZONING AND HOUSING ISSUES - California Cities for Local Control, a coalition of cities and elected officials, contacted the City Council to request support to protect local authority over zoning and housing matters due to concerns about the impact of state-level housing legislation usurping local government authority. At the September 18, 2023, City Council meeting, Mayor Pro Tem Lau requested and received support to have a support resolution added to the agenda for consideration.

RECOMMENDATION: That the City Council adopt Resolution No. 23-70, titled, "A RESOLUTION OF THE CITY COUNCIL, CITY OF LA VERNE, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, EXPRESSING SUPPORT FOR ACTIONS TO FURTHER STRENGTHEN LOCAL DEMOCRACY, AUTHORITY, AND CONTROL AS RELATED TO LOCAL ZONING AND HOUSING ISSUES."

5. RESOLUTION 23-71 APPROVING FIDUCIARY SERVICES AGREEMENT WITH THE LOS ANGELES HIGH INTENSITY DRUG TRAFFICKING AREAS PROGRAM (LA HIDTA) - In May 2022, the City Council approved the existing Fiduciary Services agreement with the Los Angeles High Intensity Drug Trafficking Areas (LA HIDTA) Program. This revised agreement increases the fee payable to the City by \$15,000, for a total amount of \$165,000 annually. This increase is to cover the heightened grant activity and the opportunity losses related to investment earnings.

RECOMMENDATION: That the City Council adopt the Resolution No. 23-71 titled, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAVERNE, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AUTHORIZING A FIDUCIARY SERVICES AGREEMENT WITH THE LOS ANGELES HIGH INTENSITY DRUG TRAFFICKING AREAS (LA HIDTA) PROGRAM", authorizing the City Manager to execute grants secured for LA HIDTA operations to be awarded in the name of the City of La Verne and appropriate \$260,000 of expenses to the Fiscal Year 2023-24 Budget within the LA HIDTA fund for the remainder of the fiscal year and \$15,000 of revenue within the General Fund.

6. ADOPTION OF ORDINANCE NO. 1120, ESTABLISHING A PRE-ANNEXATION ZONING DESIGNATION FROM THE LOS ANGELES COUNTY ZONING AND ADOPTING THE PR3D ZONING FOR 406 BASELINE ROAD IN THE CITY OF LA VERNE - The City Council at its meeting of October 2, 2023, approved the first reading of Ordinance No. 1120, establishing a pre-annexation zoning designation from the County of Los Angeles Zoning and adopting PR3D zoning for 406 Baseline Road in the City of La Verne.

To facilitate this event, the City Council is asked to approve designating all streets as a parade route and authorize double overtime for eligible participating City staff.
